

Getting hit by an 18-wheeler is not a bigger fender bender. A fully loaded truck can outweigh your car many times over, and people tend to get hurt much worse.

The difference shows up immediately. The trucking company often sends its own people to the scene the same day, before you are out of the hospital. They start protecting the company immediately.

More than one company can be responsible. The carrier, a maintenance provider, a broker, or the company that loaded the cargo may each share responsibility. Each of those is its own question with its own evidence.

Commercial trucks also create records an ordinary car never does: hours of service logs, engine and braking data, maintenance and inspection files, and the driver qualification file. A lot of it can be purged in the ordinary course of business, so a preservation demand is typically sent right away.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
