

If a bus crash injured you in Atlanta, there is a clock most people never hear about.

An ordinary Georgia injury claim generally allows two years to file. A claim against a city, county, transit authority or school district can require written notice in a fraction of that time, and it has to be in the right form and go to the right place.

A late notice can close a good claim before anyone looks at the merits.
