

If you were hurt by electrical contact around Atlanta, the answer is rarely a single company.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, and none of that is available just for the asking.
