

If an electrical injury happened at work in Atlanta, several companies may share responsibility.

There is the property owner, a general contractor, the electrical subcontractor, sometimes the utility, sometimes an equipment manufacturer, and sometimes a staffing agency. Each [atlanta personal injury attorney](#) has different insurance and different incentives to point at the others.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
