

When a rider is hurt and a driver did not see you in Georgia, the assumption is already working against you.

People arrive with a view already formed: that the rider was speeding, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes that is accurate. Usually the car turned left across a rider who had [Click for more info](#) the right [truck accident lawyer](#) of way.

Reconstruction matters more here than testimony, since the story is doubted before it is told. The geometry of the turn do the arguing.

Severity helps and hurts. There is nothing around a rider, so identical forces cause much greater harm. Expect an argument that choosing to ride was itself the risk.
