

A truck wreck is not a car wreck. A loaded tractor trailer can weigh many times what your car weighs, and the injuries are usually far worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene the same day, while you are still in the emergency room. They start protecting the company immediately.

More than one company can be responsible. The carrier, a maintenance provider, a broker, [atlanta personal injury attorney](#) or the company that loaded the cargo may each share responsibility. Each one is a separate question with its own proof.
