

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer depends on what the driver was doing at that exact moment.

When the app is off, the driver is just a driver, and their personal policy applies. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once a ride is accepted or a passenger is aboard, a much larger commercial policy typically comes into play.
