

If you ride and a driver did not see you in Atlanta, the assumption is already working against you.

Sometimes it fits. More often a driver looked and did not register a single headlight.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. The geometry of the turn carry more weight than either version of events.

Injury severity cuts both ways. A rider has no structure around them, so identical forces cause much greater harm. The defense response [truck accident lawyer](#) is often to argue the rider accepted that risk by riding at all.
