

If a dog bit you in Atlanta, Georgia [truck accident lawyer](#) works differently than people expect.

Certain states impose liability regardless of the animal's history. Georgia is not one of them. The claim generally turns on whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

This evidence does not last. County records and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
