

When a rider is hurt and were hit around Atlanta, the assumption is already working against you.

Sometimes that is accurate. Usually the car turned left across a rider who had the right of way.

The work is physical evidence, not story, because narrative starts at a disadvantage. Damage patterns carry more weight than either version of events.

Severity helps and hurts. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
