Instead of adding substantial mileage to the vehicle, the owner can arrange for a carrier to transport it to the destination. The exact benefits depend on the route, vehicle, carrier, and transportation method selected.

Vehicle transport involves loading an automobile onto a specialized carrier and moving it from an agreed pickup location to a destination. Transportation arrangements can vary depending on the vehicle's size, condition, value, route, and desired level of protection.

Some shipments use open carriers, while others use enclosed trailers. Pickup and delivery may take place at specific addresses when road and access conditions permit, or at nearby accessible locations when a large carrier cannot safely reach the requested address.

3. Research the Transportation Provider

Choosing a vehicle shipping provider should involve more research than simply selecting the lowest quote. Customers should examine the company's service information, transportation procedures, documentation, communication practices, and customer feedback.

Look for clear information about pickup and delivery, carrier types, insurance, cancellation policies, payment requirements, and potential additional charges.

4. Ask About Insurance and Protection

6. Understand Pickup and Delivery Procedures

7. Consider Door-to-Door Transportation

However, door-to-door does not always mean that a large carrier can enter a driveway or narrow street. Safety, local traffic restrictions, road width, and other access factors may require the vehicle to be exchanged at a nearby suitable location.

Customers should provide accurate address information and discuss access limitations before scheduling transportation.

8. Check the Vehicle Before Shipping

Vehicle preparation is an important part of the shipping process. Before pickup, inspect the vehicle carefully and record its condition.

Take photographs of the exterior from multiple angles. Include close-up images of existing scratches, dents, paint chips, cracked glass, damaged wheels, or other visible imperfections.

It is also useful to record the vehicle's mileage and note any existing mechanical or cosmetic issues. Keep these records until the vehicle has been delivered and inspected again.

9. Remove Personal Belongings
