

If a dog bit you in Georgia, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia is not one of them. The question is normally whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash [personal injury attorney](#) ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether a complaint was ever filed.

Records disappear quickly here. Prior complaints and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
