

If you were riding and a driver did not see you around Atlanta, you are starting from behind.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or took a risk a car driver would not.

Sometimes that is accurate. Frequently the driver simply did not see the motorcycle and turned across it.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. Scene measurements do the arguing.

Severity helps and hurts. There is nothing around a rider, so the same impact produces far worse injuries. Expect an argument that choosing to ride was itself the risk.
