

When a dog attack leaves someone hurt in Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia does not work that way. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, which is why the first questions are about where the dog was and whether a complaint was ever filed.

These records fade fast. Animal control files and **experienced personal injury lawyer** witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
