

If an electrical injury happened at work around Atlanta, the answer is rarely a single company.

There is the property owner, the general contractor, the electrical subcontractor, sometimes a utility, occasionally an equipment maker, and sometimes a labor supplier. Each has different insurance and different incentives to point at the others.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, since [truck accident lawyer](#) comp covers none of the human loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.

These injuries look survivable on day one and reveal themselves later. Scarring that requires staged revision are all common and none of them appear in the first hospital bill. ## **How long do I have to file an injury claim in Georgia?**

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
