

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, often when the bills arrive or an adjuster calls.

Georgia handles a death case differently than most people expect. Two separate claims generally exist. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering before death.

Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, [truck accident claim lawyer](#) and some of them are shorter than **truck accident lawyer** the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, particularly where a commercial vehicle or a business is involved.
