

How this Anion Gap Indicates

The **anion gap** is a computed value that helps clinicians measure the balance between measured positive ions and measured negative ions in serum testing. An **Anion Gap Calculator** commonly uses **serum sodium**, **serum chloride**, and **serum bicarbonate** from an **electrolyte panel** to help estimate whether there are extra, **unmeasured anions** existing in the blood.

Frequent Causes of Metabolic Alkalosis

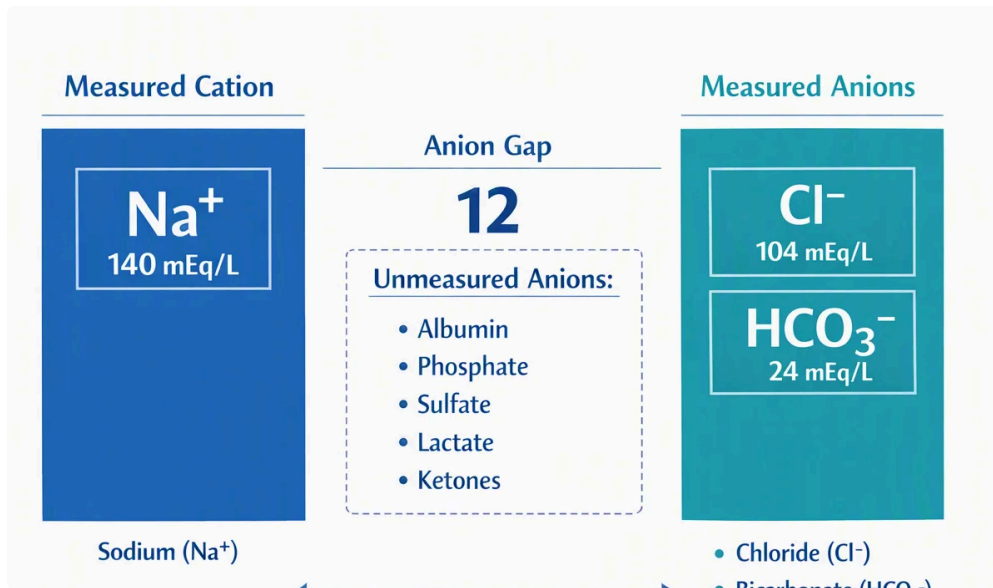

When to Order Additional Tests

Extra workup is warranted when the anion gap result does not fit the overall presentation or when symptoms point to a second process. If the patient appears sick, with low blood pressure, dehydrated, or has unexplained tachypnea, additional assessment is needed. The goal is to identify any hidden metabolic stress alongside the alkalosis.
