

If an electrical injury happened at work around Atlanta, the answer is rarely a single company.

There is the property owner, a general contractor, the electrical subcontractor, sometimes the utility, sometimes an equipment manufacturer, and sometimes a staffing agency. Each has different insurance and different incentives to point at the others.

Workers compensation pays medical bills and a portion of lost income when the injury [truck accident lawyer](#) is work related, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, since comp covers none of the human loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
