

If you were riding and a driver did not see you around Atlanta, the assumption is already working against you.

There is a built in bias in motorcycle claims: that the rider was speeding, was weaving through traffic, or took a risk a car driver would not.

Sometimes that is accurate. Usually the car turned left across a rider who had the right of way.

Reconstruction matters more here than testimony, since the story is doubted before it is told. Scene measurements carry more weight than either version of events.

Injury severity cuts both ways. There is nothing around a rider, so the same impact produces far worse injuries. Expect an argument that choosing to ride was itself the risk.
