From the chaos of scheduling to the adrenaline spikes in the cage, it's an unforgiving routine that messes with your sleep, mental state, and ultimately your health. A common lament I hear from fans, broadcasters, and anyone who's ever braved a live fight card: "How on earth do you stop jumping out of bed every time a fight ends early?" All of this leads to **fragmented sleep** — where you cycle in and out of light sleep phases, making you easily startled awake by sudden noises or adrenaline surges.

Corner Management's Role in Sleep Disruption

While it's a key component of **card pacing** and fighter performance during the event, corner management activity often starts well before fight announcements and continues well after. For journalists and fans relying on after-hours broadcasts or phone alerts, the voluminous audio activity can be startling or distracting in quiet hotel rooms or shared environments.



Time Zone Shifts and Circadian Disruption

Finally, consider the **time zone hops** fighters and many attenders make for events. Even with the best intentions, circadian rhythms rarely realign perfectly in just a few days, leaving the melatonin and cortisol cycles out of sync.

Circadian disruption degrades both the amount and quality of sleep, decreasing the threshold for being awakened by adrenaline or external stimuli — such as unexpected fight conclusions.

How to Combat Circadian Disruption

- Use timed exposure to bright light and darkness, guided by apps or simple timers.
- Schedule meals and caffeine usage to reinforce local time cues.
- Keep regular wake and sleep times even during exciting fight weekends.

Strategies to Manage Fight Week Sleep and Early Fight Endings
