

What Is an Anion Gap and Why Does It Matter?

The **anion gap** is a helpful way to assess **metabolic acidosis** and determine whether extra acid is likely occurring in the blood. It shows the difference between the major measured cations and anions on a basic **serum electrolytes** or serum chemistry panel, most commonly using **serum sodium**, **serum chloride**, and **serum bicarbonate**. Because many acids are not directly measured, the anion gap helps uncover an **anion difference** that points to hidden acid accumulation.

Toxic alcohols are a major consideration in unexplained high anion gap states. In these cases, rapid recognition is essential.

The key point is that a high gap is a signal, not a final answer. It should prompt a focused search for the underlying cause rather than stand alone as the diagnosis.
