

When someone is shocked or burned on a job site in Georgia, several companies may share responsibility.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. That third party claim is usually where the real recovery sits, since comp covers none of the human loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
