

A truck wreck is not a car wreck. A fully loaded truck can outweigh your car many times over, and the injuries are usually far worse.

The difference shows up immediately. Trucking companies frequently send an investigator to the scene the same day, while you are still in the emergency room. They begin building the company's side of the case right away.
