

A truck wreck is not a car wreck. A fully loaded truck can outweigh your car many times over, and people tend to get hurt much worse.

The difference starts in the first hours. Trucking companies frequently send an investigator to the scene before the road is even clear, before you are out of the hospital. They start protecting the company immediately.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
