

A truck wreck is not a car wreck. A loaded tractor trailer can weigh many times what your car weighs, and the injuries are usually far worse.

The difference shows up immediately. Trucking companies frequently send an investigator to the scene before the road is even clear, while you are still in the emergency room. They begin building the company's side of the case right away.
