

If a dog bit you in Atlanta, Georgia works differently than people expect.

Some states hold the owner responsible no matter what. That is not the Georgia rule. The question is normally whether the owner knew the animal was dangerous, or whether a [car wreck injury lawyer](#) leash law was being broken at the time.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. Prior complaints and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
