

If you were riding and someone turned across your path in Atlanta, there is a prior you have to overcome.

There is a built in bias in motorcycle claims: that the rider was speeding, was lane splitting or weaving, or took a risk a car driver would not.

Occasionally that is true. More often a driver looked and did not register a single headlight.

Reconstruction matters more here than testimony, since the story is doubted before it is told. The geometry of the turn do the arguing.

Severity helps and hurts. There is nothing around a rider, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
