

A truck wreck is not a car wreck. A fully loaded truck can outweigh your car many times over, and the injuries are usually far worse.

The difference shows up immediately. The trucking company often sends its own people to the scene before the road is even clear, while you are still in the emergency room. They start protecting the company immediately.

More than one company can be responsible. The carrier, a maintenance provider, a broker, or the company that loaded the cargo may each share responsibility. Each of those is its own question with its own evidence.

Much of it can be overwritten or discarded on a normal schedule, so a preservation demand is typically sent right away.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
