

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer turns on what the app was doing when the crash happened.

When the app is off, the driver is just a driver, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a smaller layer of coverage generally applies. Once they have accepted a ride or have a passenger in the car, a much larger commercial policy typically comes into play.

How much does a personal injury lawyer cost in Atlanta?

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
